4 First Aid Measures

Description of necessary first aid measures:

6 Accidental Release Measures

Personal precautions, protective equipment and emergency procedures:

For non-emergency personnel: No action shall be taken involving personal risk or without suitable training. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate protective equipment.

For emergency responders: If specialized clothing is required to deal with the spillage, take note of any information in section 8 on suitable and unsuitable materials. See also information in "For non-emergency personnel".

<u>Environmental precautions:</u> Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Methods and materials for containment and cleaning up:

Large spill: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water

courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in a container for disposal according to local regulations (see Section 13).

7 Handling and Storage

Precautions for Safe Handling:

<u>Protective measures:</u> Put on appropriate personal protective equipment (see Section 8). Do not handle until all safety precautions have been read and understood. Do not get in eyes, skin or clothing. Do not ingest and avoid breathing vapour or mist. Keep in the original container or an approved alternative made from compatible material, kept tightly closed when not in use. Empty containers retain residue and can be hazardous. Do not reuse container.
